

<u>From the South:</u> Take BUSINESS HWY 371 to the stoplight at Co. Rd. 117 (or Thiesse Rd.) turn right, at the stop sign, turn left onto 13th Street. It's on the right; you can't miss it!

Vendors will enter the gate north of the building (about a block beyond the public parking lot) Watch for club members in orange vests to direct you.

<u>From the North, East or West:</u> Take Hwy 210 to SE 13th Street. Turn south on 13th Street. The Fairgrounds will be on your left.
